Private Label Rights Terms and Conditions

Note: the license and instructions you are reading now must be passed on, without alteration, to your customers if you are reselling the Private Label Rights. You may ignore this instruction if you are only selling the product without Private Label Rights.

With the **Private Label Rights** (and **Master Rights**) to this product, you can do any or all of the following:

1. **Put your name as the author** on the product.
2. **Re-title and/or edit the contents.** You can add, remove or edit the contents of the product and insert your own links and affiliate links for back-end income.
3. **Change the eCover.** The source file to 3D and flat eCover can be edited in Adobe Photoshop – you can change the color, add in your name, re-title the product, or anyhow you like.
4. **Change and/or edit its pre-written sales letter.** You can put your name on the sales letter, rewrite it, collect and compile your own testimonials and endorsements into the sales letter, or anyhow you like.
5. **Sell the Information Product (eBook).** Sell it in PDF format at the suggested price of \$37.00.
6. **You can convey Basic/Master Resell Rights** to the product (PDF eBook) and sell at a higher suggested price of \$97.00.
7. **You can resell the Private Label Rights to the source code.** The suggested selling price is \$197.00. Your customer can in turn resell the Private Label Rights, too.
8. **You can chop the product into several articles and mini reports.** Add in your own resource box and submit to article and eBook directories for viral marketing exposure.

9. **You can create content for your online newsletter or eCourse.** Chop the product and create multiple contents for your subscribers' interests.

The **restrictions** are:

1. You **CANNOT** give away the Private Label Rights to the product for free.
2. You **CANNOT** under any circumstances offer more than 2 Private Label products from the PLRGold package in a bundled package, paid membership site, or bonus.
3. You **CANNOT** use unethical marketing methods or SPAM to conduct your business with this product.
4. You **CANNOT** sell this product, in whatever format, on auction sites such as eBay.com.
5. You **CANNOT** add, use or impersonate my name (Edmund Loh), business name (PrivateLabelRightsGold.com) or any other of my business or personal information to the product. This product is for your own use, not mine.

Upon opening the product source code (.doc file), Search or press "CTRL-F" in Microsoft Word environment and replace all "[Insert Your Name Here]" texts with your own name as the author.

This product can be claimed authorship by you. However, you are advised to scan through the product thoroughly and replace any other relevant information of yours or your business for that matter such as your own affiliate links, eZine name, business site URL, and the such.

The Sales Letter

Upon opening the sales letter source code (.htm file), search and replace all pink text with your own details. You are free to edit the sales letter whatsoever.

The Thank You Page

Edit the download links in the Thank You Page to redirect your customers to download the product in your server. Search and replace all pink text with your own details. You are free to insert your own ads or back-end selling in this page.
